


Back-Up Alarms must be tested each day prior to vehicle appration. A record of this test must be recorded in the vehicle maintenance file.


IMFORTANT. This unit is a safety downer, and must be connected to it's own separate. Fused power point to assure its continued operation should any other electrical accessory (bit.

- A. Select a convenient location for mounting the switch, either at the reverse gear linkage or shift lever, so the outer end of the switch actuating arm (1) will be moved a minimum of one inch, when vehicle is put into reverse goar. Contact with the actuating arm should be made approximately 1 ½° from the end.
- B. Throad two 14 or 16 gage wires to this switch location. One from the positive terminal of the back-up alarm (red wire or front terminal) and the other from a good source of electricity.
- C. Remove lower switch housing (2). Install wire clarrip (3) and insert wires through clamp. Connect one of the wires to the terminal marked "COMMON".
 - NOTE: To improve moisture resistance, upply a scaling compound around wires at clamp. Staller reasonably.
- D. Unscrew hex nuts from switch mounting bolts (4) and attach mounting bracket (5). Be sure that sealing washers (6) are in place between bracket and switch. Solt bracket in position on vehicle.
- E. Check back-up alarm system for proper operation before using vehicle. If alarm does not function, reverse power leads to alarm. If alarm still does not function, check to make sure actuating arm is moving one inch. CAUTION: the switch is designed to Handle the current draw of back-up alarms. No other contains can be added to system with out endangering life of switch.

A MECHANICAL SWITCH FOR USE WITH BACK-UP ALARMS

Install the switch adjacent to the gear shift lever so that shifting into reverse will move the switch actuator arm sufficiently to make electrical contact.


